RULES AND REGULATIONS GOVERNING USE OF THE RACCOON TWP MUNICIPAL PARK

- 1. Park is open daily from 7 AM to 10 PM. All activities in the park shall cease and all persons shall leave the park as soon as possible thereafter. No person other than authorized employees thereof shall be in the park between 10 PM and 7 AM on the following morning.
- 2. No removing or changing position of any bench, seat, or table without written permission of the Township.
- 3. No defacing, removing, cutting, or damaging of any trees, plants, shrubs, turf, building, structures, or fixtures therein, or any other property of the Township located within the park.
- 4. No person shall hold any meeting, or gathering assembled through advertisement, or public notice, or any gathering otherwise assembled and composed of 10 or more persons, within the limits of the Park, without first making application for a permit thereof. Each permit will require a deposit and rental for any shelter or facility used by the group. The application for such permit shall be in the name of the person who shall be responsible for seeing that all refuse left by the group will be placed in proper containers before leaving the Park. Those with a permit for use of a specific facility or location shall have priority over those without a permit.
- 5. No setting up of any booth, table, or stand for the sale of any article whatsoever within the limits of the Park without the written consent of the Township which shall have the authority to refuse such consent in any instance.
- 6. No disposing of any litter, waste, or garbage in the Park. All persons using the Park shall dispose of all waste and garbage left by them in such proper receptacles.
- 7. No injuring, defacing, or destroying any notice, rule or regulation posted at any place within the Park by Authority of the Township. No posting, at any time, any notice or placard other than that by authority of the Board.
- 8. No setting or maintaining any fire in the Park except in stoves and fireplaces maintained for the purpose and located by authority of the Township. As hereinafter set forth, only charcoal and/or wooden fires are permitted. In the event a wooden fire is instituted, any wood so utilized shall be brought from outside the Park. NO OPEN FIRES PERMITTED.
- 9. No use, possession, transportation, or consumption of alcoholic beverages within the Park.
- 10. No person, other than an officer of the law, shall carry any firearm within the limits of the Park. No engaging in archery sports of any function involving force propelled devices unless approved by the Township.
- 11. No operating or cause to have in his possession any unlicensed motor vehicle or cycle.
- 12. No unrestrained pets in the Park.
- 13. No parking and/or driving in areas other than designated parking areas or on paved roadways.
- 14. Speed limit within the territorial confines of the Park shall be five (5) miles per hour as indicated by the posting of signs stating such fact.
- 15. No climbing any tree, no sitting, standing or walking on any park sign, park structure, or park building not customarily utilized for such purposes.
- 16. No person shall erect tents, shacks, shelters, trailers, recreational vehicles, or any other structure for overnight camping or otherwise, without express Township approval.
- 17. No operating remote control and/or hobby devices permitted within the confines of the Park unless approval is obtained from the Township.
